Delivery time and location: The services or supplies contained in this contract will be delivered as outlined below. It is understood that some decisions may be made or changed subsequent to this contract. By signing this contract, the purchaser consents to the delivery of supplies and services within 30 days; any refund to be issued should contract be cancelled will be reduced by the value of supplies and services already delivered.

Warranties: The Provider warrants that it will provide the services agreed to in this contract to the best of its abilities. The warranties granted in connection with the supplies provided as part of this contract are the express written warranties, if any, extended by the manufacturer of such supplies, and as required by Ontario consumer protection legislation.

Payment terms: Unless otherwise specified, payment is due by the day the services are completed after which interest will be charged on any overdue amount at the rate of 1.5% per month (18 % per annum) until the date payment is made in full.

Failure to pay: If the purchaser fails to make payment within the time period set out in this contract, collection action may be taken against the purchaser; the provider may hire a collection agency to collect the amount owing, including interest charges. Not limited to any court fees and lawyer fees associated with collection in Ontario Small Claims Court.

Substitution: the Provider will make reasonable efforts to obtain and provide the services and supplies agreed to in this contract. If the Provider and the person entitled to cancel this contract agree, the Provider may substitute a supply or service, which will be of comparable quality and value, and similar in style, design and construction to, the supply or service that is unavailable. The substitution will be made at no increase in price. If the Provider is unable to obtain and provide a service or supply, the Provider will provide a refund of the sum of the initial amount paid for the supply or service and any income earned on the amount paid. The Provider will inform the person entitled under this contract to cancel this contract, of the refund. This contract may be cancelled in accordance with the terms of cancellation.

Commissions and Benefits: The Provider will receive consideration or benefit from the following third party suppliers for referrals or recommendations: St. Johns Cemetery (up to \$40.00), Holy Cross Cemetery (up to \$40.00).

Cancellation Rights: The purchaser, or someone designated in this contract by the purchaser, may cancel this contract by providing notice of the cancellation in writing to the Provider. A partial or full refund of money paid, if any, may be available based on the terms of this contract and the law. Any refund owed will be issued within 30 days.

If this contract meets all of the requirements of the Act and is cancelled within 30 days of this contract date and before any services or supplies have been provided, the Provider will refund all amounts paid under this contract.

If this contract meets all of the requirements of the Act and is cancelled after 30 days of this contract date and before any services or supplies have been provided, the Provider will refund the amount paid under this contract plus any income earned on the amount paid or that should have been earned on the amount paid if it had been deposited as required, but the Provider may retain an additional 10% of the amount paid to a maximum of \$350.

If this contract meets all of the requirements of the Act and is cancelled after some of the services or supplies have been provided as directed under the terms of this contract, the maximum refund required will be the amount paid under this contract plus any income earned thereon or that should have been earned if it had been deposited as required, and in some cases permitted by the Act, the Provider may retain the value of the services and supplies that have been delivered.

If this contract fails to meet the requirements of ss.40(1) of the Act, the maximum refund required will be the amount paid under this contract plus income earned thereon or that should have been earned if it had been deposited as required. In some cases permitted by the Act, the Provider may retain the value of the services or supplies that have been delivered.

Customized supplies: Any supplies that are customized may not be cancelled after the customization has been started; this includes but is not limited to, urns, monuments, grave markers, memorial cards, etc. The purchaser may cancel these items before the customization has been started, and will receive a full refund of any money paid toward this item.
